The calendar opens on the 15th of every month, for the following month. (eg. On January 15th at 7pm, February's calendar will be open.)

If the calendar is gray, **no** appointments are available. If any cancellations occur, they will be automatically reflected online so you can check periodically for available appointments.

(New Clients)

You **must** schedule a 'New Client Consultation' in addition to your desired service(s). The 'New Client Consultation' can (not) be booked alone.

The 'New Client Consultation' can be found under the 'add on' section once you have selected your service(s).

If you are unsure of what service to book or are only interested in a Client Consultation, Virtual Consultations are available.

If you are a new client and you book a service without adding on the " New Client Consultation " , your appointment will be anceled and your deposit will be forfeited.

(Deposits & Pricing)

Depending on the desired service, each deposit is a different amount.

ALL deposits are non-refundable.

Your deposit will be deducted from the total cost of your service(s). All deposits will be taken with your card info when you book through this site. However, your balance must be paid via Zelle, PayPal, or Cash the day of your appt.

When booking, prices will vary depending on your hair length and density. Please read all service descriptions and book according to the listed variations.

Be sure to include ALL the desired 'Add on' services while you are booking your appointment. Add ons can not be made upon arrival.

(Restrictions & Limitations)

NO EXTRA GUEST OR CHILDREN.

If you have any allergies or prescribed medication that you must use during your visit, please let us know prior to being serviced.

If you have any cuts , scratches, scabs, or open wounds we will not be able to service you due to sanitation purposes.

Please arrive with your hair **fully detangled**. **NO braids or twist** should be in your hair. If you are unsure on how to properly detangle your hair, there is an option to add on “**extra detangling**” at your time of booking.

(Cancellation, Rescheduling, & Tardy Policy)

Please be on time - however *do not* arrive more than 5 mins prior to your appt time. Early arrivals will not be seen until their scheduled time.

In the event that you have to cancel or reschedule your appointment, please give us a 48 hour notice. Cancellations that occur within 24 hours of the appointment will be charged 50% of the service fee.

No call no shows will be removed from the clientele list, and will be charged 100% of the service fee. The fee is non-refundable.

When rescheduling an appt, you are allowed up to one deposit transfer. Your desired rescheduled date must be within 1 - 2 weeks of your original appt. date. If your desired rescheduled date is more than 2 weeks, the deposit transfer will not apply to your appt.

Here at the Studio we strive to service all our clients in a timely fashion, therefore if you are **running late** - please give us at least 15 mins notice. We will always try our best to accommodate you. There is a 8 min grace period, however after 8 mins a late fee of \$10 will be added to your balance. After 15 mins, your appointment will have to be canceled, rescheduled, or the service(s) will be altered. This decision will be up to the stylist.

The full address details will be sent to you via email 24 hours before your appt.
